BYLAW NO. 2575

A BYLAW TO AMEND BYLAW 2165 "SATURNA ISLAND FIRE PROTECTION AND EMERGENCY RESPONSE LOCAL SERVICE CONTRIBUTION ESTABLISHMENT BYLAW NO. 1, 1993"

WHEREAS a Regional District may, by bylaw, establish a local service under Section 798(1)(m) of the *Municipal Act*_to provide contributions to the costs of a service referred to in paragraph (g), inter alia, of Section 798, that is provided within the service area by another person or association;

AND WHEREAS the Regional Board established by Bylaw 2165 a local service for the purpose of contributing to the costs incurred by the Saturna Island Fire Protection Society of providing fire prevention and suppression and emergency response services on Saturna Island Electoral Area "G" (Outer Gulf Islands);

AND WHEREAS the consent is given on behalf of the electors in the proposed participating area by the electoral area director consenting in writing to adoption of the bylaw under Section 811(2) of the Municipal Act;

NOW THEREFORE the Board of the Capital Regional District in open meeting assembled, enacts as follows:

- 1. Bylaw No. 2165, "Saturna Island Fire Protection and Emergency Response Local Service Contribution Establishment Bylaw No. 1, 1993" is hereby amended by:
 - (1) deleting the section 6 and replacing it with the following:
 - "The maximum annual amount that may be requisitioned for the cost of the Local Service will be the greater of:
 - (a) Forty One Thousand and Four Hundred Dollars (\$41,400.00); or
 - (b) an amount equal to the amount that could be raised by a property value tax rate of \$0.487 per One Thousand Dollars (\$1,000) which when applied to the net taxable value of lands and improvements within the Local Service Area, will yield the maximum amount that may be requisitioned under section 816 (1) (a) of the Municipal Act for the service.
